

It is my opinion, and the opinion of many others, that staff and the AFAC have focused on confirming the AFAC vision developed by the Cornerstone report, and not asking the community for their vision. It may be seen as a very biased process. The architect, in the visioning process, has not consulted the community with an unbiased focus. The focus has been strongly on confirming the vision, not on a governance model and a capital funding plan. Finally, after many months, the architect has hired a Toronto governance consultant. It has also taken many months to start working with a capital fund raising consultant. A governing model and a capital funding plan were the priorities given by Council. That has not taken place. Why has a Toronto governance consultant been hired by the architect? Are there governance specialists in Metro Vancouver?

Really, the most often asked question, as staff and AFAC continue to comment that a site has not been chosen, is why are \$, staff and AFAC time, being spent on a back to front process. A vision for a facility where the site hasn't been identified? How can that be? Visioning for a facility for a site in Ambleside Park - either the tennis courts or the parking lot - would be completely different. Visioning for a facility for a site that could be at the library, the community centre, the Gertrude Lawson house, or 15th and Fulton would be completely different again. So, we continue to ask the question, why has the visioning been done first and with the majority of time and \$?

The process should have been: site, vision for the particular site, how to fund what we want to be built on that site, and how to govern what will be built. Very few in our community understand why the process has been what it is.

When analyzed more than 50% of respondents did not want the facility placed in Ambleside Park. It seems that "Ambleside Park" is consistently left out of this communication even though staff and the AFAC are working with two locations in "Ambleside Park" as the identified site, with a third location in Ambleside Park as a possibility.


Council directed that additional community-wide engagement program on the next steps for arts and culture facilities in West Vancouver and the development of a governance model and a Capital Funding Plan for the replacement of the facilities for arts and culture in West Vancouver be undertaken.

It is my opinion, and the opinion of many others, that staff and the AFAC have focused on confirming the AFAC vision developed by the Cornerstone report, and not asking the community for their vision. It may be seen as a very biased process. The architect, in the visioning process, has not consulted the community with an unbiased focus. The focus has been strongly on confirming the vision, not on a governance model and a capital funding plan. Finally, after many months, the architect has hired a Toronto governance consultant. It has also taken many months to start working with a capital fund raising consultant. A governing model and a capital funding plan were the priorities given by Council. That has not taken place. Why has a Toronto governance consultant been hired by the architect? Are there governance specialists in Metro Vancouver?

Really, the most often asked question, as staff and AFAC continue to comment that a site has not been chosen, is why are \$, staff and AFAC time, being spent on a back to front process. A vision for a facility where the site hasn't been identified? How can that be? Visioning for a facility for a site in Ambleside Park - either the tennis courts or the parking lot - would be completely different. Visioning for a facility for a site that could be at the library, the community centre, the Gertrude Lawson house, or 15th and Fulton would be completely different again. So, we continue to ask the question, why has the visioning been done first and with the majority of time and \$?

The process should have been: site, vision for the particular site, how to fund what we want to be built on that site, and how to govern what will be built. Very few in our community understand why the process has been what it is.



Below is Natalie Roizman's response on Sep 14th/22 followed by my original email to Mayor and Council.

Your correspondence regarding lowering of flags at municipal facilities and the decision to hold the Arts Facilities Advisory Committee (AFAC) meeting on Thursday, September 8 has been forwarded to staff for a response as it is regarding operational matters.

Official guidance from the United Kingdom government advises that: "following the death of Her Majesty The Queen, all official flags should be half-masted as soon as possible that day." I can confirm that all District-owned flags were lowered as soon as possible. Some of the flag poles at District facilities, such as the Ferry Building, require a lift truck that must be operated by staff who are trained to use this specialized equipment. When the announcement of The Queen's passing was made, staff confirmed that District flags would be lowered, and redeployed the appropriate staff from their current duties as expeditiously as possible to carry out this task.

Regarding cancelling public meetings, and in particular, the AFAC meeting that was held on Thursday, September 8, I can also confirm that staff looked into the matter and determined that there are no statutory or other requirements to suspend District business due to the Queen's passing. If the Chair, in consultation with staff, decides to cancel the meeting then they are welcome to do so as per the Council Committee Procedure Bylaw. Additional guidance from the UK government also states that businesses, public services and other organizations have no obligation to cancel or postpone events or activities during the period of mourning for the Queen.

What actions should have been taken but were not?



Only because of her efforts in contacting Municipal Hall (first left a voicemail, then sent an email) did the employee eventually get those flags lowered but by now it was mid-afternoon.
- 2) The District of West Vancouver failed to IMMEDIATELY cancel all its public meetings. There was one published meeting scheduled that day, the Arts Facilities Advisory Committee (AFAC) Capital Funding Subcommittee at 4 PM via electronic communication facilities. Seeing on the District's website that this meeting was still listed to occur, I emailed the heads of the Community Relations / Communicatons department and the Cultural Services department to request it be cancelled out of respect. Unbelievably, the cancellation decision was then deferred to the AFAC subcommittee co-chairs (who are citizens not District staff!) who then made the grave error to carry on regardless with business as usual and hold the meeting. The burden of this decision should never have been placed on these two people but still, the magnitude of this day and the obvious need to cancel that day's meeting, was inconceivably lost on them. Per its modus operandi, this Committee put itself and its single-minded agenda first and once again failed to live up to its own Terms of Reference i.e. Committee members are required to possess 'an ability to look beyond personal interests for the benefit of the community and residents of West Vancouver'.

It's a given. All flags at our public buildings should have been immediately lowered to half mast. All meetings that involved the public that day should have been immediately cancelled.

The incompetence on display that day was clearly evident. Shame on our Mayor, shame on our Municipal Hall staff, and shame on AFAC. There is no explanation or excuse or words you can say to appease your blatant lack of respect to our Queen and your outright failure and lack of duty to the citizens of West Vancouver. Disgraceful!

God help us all the next time quick and decisive leadership is urgently needed in West Vancouver.

The Aquatic Ecosystems Restoration Fund (AERF) supports projects that conserve and restore marine ecosystems. Projects will cover all of Canada's coasts and further inland to create opportunities for freshwater and oceans sectors, and coastal and upstream inland communities.

The Government of Canada supports efforts to address threats within aquatic ecosystems to protect aquatic species and promote sustainable aquatic environments. This work will also help ensure continued economic prosperity for coastal and inland communities across the country.

During the next phase of the Oceans Protection Plan, Aquatic Ecosystems Restoration Fund projects will address impacts on Canadian aquatic environments on all coasts. Four years ago, Canada became a leader in the world by legalizing recreational use of cannabis. However significant issues remain that need to be addressed for patients and industry alike. I have assumed the Chair of the All-Party Parliamentary Cannabis Caucus to help provide advice on the review of the Cannabis Act, engaging with industry, and helping chart the path forward.

Locally, I had the opportunity to join Randy Boissonault, Canada's Minister of Tourism, for an announcement of a \$1.2 million investment into BC's tourism sector, including funding for Harbour Air to begin service to Squamish. We were also honoured to meet a delegation of parliamentarians from France visiting Whistler and Squamish to learn from each other in topics ranging from culture to clean technologies.

We also marked Small Business Week from the 15th-21st by visiting and hearing from small businesses across the riding. You can view a snapshot <u>here</u>.

I was especially proud to celebrate the official grand opening and ribbon cutting at Westwinds Senior Living in Squamish, a project which received over \$40 million in funding by the federal government that is now housing over 300 seniors in affordable housing in our community.

I am committed to engaging youth in our democracy and government. As part of our Constituency Youth Council's last project, I visited classes at Chatelech Secondary in Sechelt and Mulgrave in West Vancouver with our CYC members to present how the Government of Canada works, my role as an MP, and most importantly, we had a discussion on the issues that matter to young people and our community. It was great hearing directly from youth and engaging with them on some really important issues.

Given the actions of the tyrannical regimes in Iran and Russia and the devastation it is causing to the Iranian and Ukrainian people around the world, amongst so much other global turmoil, I was reminded how privileged we are to be living in Canada this past Thanksgiving and always. Canada stands with the brave people of Iran and Ukraine fighting against tyranny, and we have announced additional sanctions on the perpetrators of these atrocities, while we work individually and collectively with the civilized world to counter the actions of these regimes and to stand up for human rights.

# **Parliamentary Updates**

#### Bill C-29 - The National Council for Reconciliation Act

On Indigenous and Northern Affairs Committee, we've been continuing the work on Bill C-29, the National Council for Reconciliation Act. This important bill will establish the National Council for Reconciliation in order to fulfill the Truth and Reconciliation Commission's (TRC) Calls to Action 53-56. The Council will be a permanent, independent, and Indigenous-led organization, monitoring and supporting the progress of reconciliation in Canada, including the full implementation of the TRC Calls to Action. This Council will be a vital tool to help keep both our government and future governments accountable for their obligations to Indigenous people and to make real, concrete, quantifiable progress towards reconciliation. We have been hearing from witnesses on ways that we could potentially make this bill better and stronger, and I'm looking forward to getting that opportunity as we move forward with it at committee.



Bill C-248, An Act to Amend to the Canada National Parks Act (Ojibway National Urban Park of Canada)

On the Environment and Sustainable Development Committee, we have been hearing from witnesses in relation to a Private Member's Bill that would create a new National Urban Park near Windsor in an area of significant ecological importance. Parks Canada has been in the process of evaluating and consulting with Indigenous groups and other communities on the creation of a larger park in this area for multiple years. The Committee is now grappling with how and if the proper due diligence, consultations, and protections can be established through this unusual process of park creation.

# Study on Clean Technologies

The Environment Committee recently wrapped up hearings on our study on Clean Technologies and will now begin the process of drafting a report on our findings. We've heard from clean tech companies and other expert witnesses across Canada that have identified

the major opportunities and barriers that Canada faces in the clean tech sector and provided advice on the path forward for the Government of Canada.

# **Parliamentary Tourism Caucus**

In my role as Co-Chair of the Parliamentary Tourism Caucus, I've been very busy as we look for ways to help build back our tourism industry after the pandemic. While the tourism sector in our region has been remarkably resilient through the pandemic and in some cases actually ahead of pre-pandemic levels, the picture is less positive across the country.

My co-chair Senator Karen Sorensen and I hosted meetings with leading tourism associations, roundtables with representatives from every sector of the tourism industry, and receptions with stakeholders and parliamentarians to talk about the challenges facing the industry and the solutions that we can employ to help make Canada a world class destination once again.



# **All-Party Parliamentary Cannabis Caucus**

I have assumed the Chair of the All-Party Parliamentary Cannabis Caucus from MP Nathaniel Erskine-Smith. Canada became a world leader when in 2018 we became only the second nation in the world to fully legalize and regulate the recreational use and possession of cannabis. Canada recently launched a review of the Cannabis Act to address remaining issues such as the continued presence of the illicit market, patient access, barriers and impacts to Indigenous peoples, and much more.

While the legal industry has grown to contribute over \$43.5 billion to our economy and 43,000 direct and 151,000 indirect jobs across the country in just four years, it continues to face multiple challenges such as competition from the illicit market, significant red tape and high taxes that need to be addressed through a new government/industry working group. My plan is to use this new position as chair to work across party lines to find mutually agreeable ways to help chart a better path forward.

# Standing in Solidarity with the People of Iran

It's been over 40 days since Mahsa Amini died. Since then, we have seen brave women and men in Iran rise up against the brutal repression and human rights abuses carried out by the Iranian regime. Protests at over 200 cities have sprung up in solidarity. Canada has announced new measures to hold the regime accountable, including economic sanctions, permanent expulsion of the perpetrators from Canada, and measures to strengthen public safety locally. I hosted a community discussion with constituents on October 7 about the events unfolding in Iran. They shared their thoughts and concerns, as well as suggestions on how the government can respond better. Thousands gathered the next day in support of those fighting for their rights in Iran - check it out!

I also was honoured to join members of the Iranian-Canadian community as well as my parliamentary colleagues at a vigil in Ottawa on October 26 and a couple other demonstrations in Vancouver this month. The turnout at these protests has been incredible and inspiring. Canada will continue to do what we can to hold perpetrators accountable, demand justice, and fight for human rights in Iran.



# Constituency Youth Council School Presentations & Discussions

We had two school visits this month with our Constituency Youth Council (CYC). The first was at the Law Studies 12 at Chatelech Secondary where we discussed civics and government. I was pleased to have Colten, CYC member on the Coast, accompany me. He spoke about the benefits of the CYC and did a tremendous job of co-facilitating our presentation on a variety of government topics. Thank you to Rod Millican, their teacher, for inviting us to your classroom, to the students for their great questions and active engagement, and to Colten for his passion and leadership on the CYC.



I also had the great pleasure of speaking to the students at Mulgrave School in West Vancouver, where my CYC members and I held a fantastic civics presentation and youth discussion. After the presentation, students asked some thought-provoking questions on a range of topics, from international affairs to income inequality. Thanks to Mulgrave for having me and a special thank you to CYC members Colten, Jeanette, Jaiden, and Anthony for presenting with me.

# Tourism Relief Funding Announcement



On October 14, I joined my colleague and friend Randy Boissonault, Minister of Tourism, for a tourism funding announcement of \$1.2 million into BC's tourism sector, which will benefit four major tourism projects in the province, including support for constructing a new sea plane terminal in Squamish for Harbour Air. This is going to be hugely beneficial for tourism here in our region, as people will have easier access from Squamish to major destinations on flights from a company that has been net-zero in emissions for over 15 years, and that is piloting the first electric commercial flights in the world.

#### **Small Business Week**

This month, I visited a number of some small businesses in Dundarave to mark Small Business Week, which celebrates local entrepreneurs and everything they do for our communities and the economy. I took the time to chat with owners and hear directly from them about their priorities and concerns.



#### **Celebrating the Sechelt Arts Festival**

The 19th annual Sechelt Arts Festival opened this month at the Seaside Centre. The 2022 theme of the flagship festival is "Upcyle", bringing greater focus to everyday issues such as conserving versus discarding. The Seaside Centre was alive with music from the Jun Yard Bad as the festival producers announced the many festival events that touch on this theme of repurposing our trash, cast-offs or old ideas into new presentations of visual art, drama dance, music and even heritage. Thank you to the Sechelt Arts Council and volunteers who bring so much joy to this community through their experience, values, beliefs, and art.

National Day of Action for Missing and Murdered Indigenous Women, Girls, and LGBTQ2S+ people



October 4 marked the National Day of Action for Missing and Murdered Indigenous Women, Girls, and LGBTQ2S+ people, and I was honoured to attend, listen, and light candles with the community at the event hosted by Squamish Nation in partnership with My Sea to Sky and Justice for Girls.



# **Opening the Westwinds Senior Living Complex**

On October 5, we celebrated the official grand opening and ribbon cutting at Westwinds Senior Living in Squamish. This five-storey building located in downtown Squamish provides 232 affordable rental homes for low to moderate income seniors. The federal government supported the project with more than \$40 million in funding, and worked in partnership with BC Housing, the District of Squamish, Squamish Senior Living Society, and Polygon Homes.



This project is yet another example of what we can do when we get different levels of government working together towards a common goal of expanding affordable housing in our communities.

# 40 Years of Service - Celebrating the Howe Sound Women's Centre

The Howe Sound Women's Centre celebrates 40 years in the Sea to Sky this October and hosted a wonderful, memory filled open house in Squamish this week. The HSWC has been a strong advocate in the community, raising awareness about the issues of violence against women, pushing for affordable housing, and working to create more resources to meet the betterment of the women and children in the Sea to Sky. They serve the entire Corridor, providing crisis support, referrals, advocacy, multicultural outreach, emergency housing, and counselling. They operate a centre in Squamish and Whistler, a safe home in Whistler and Pemberton, and transition house in Squamish.

# 2023 Constituency Youth Council Applications
