I hereby release and agree to hold harmless West Vancouver from any liability by virtue of any alteration or use in composite form whether intentional or otherwise, that may occur or be produced in West Vancouver's use of the Film Entry. I agree that West Vancouver owns the copyright to the Film Entry and waive any claims I may have based on any usage of the Film Entry derived therefrom. I am of full age and competent to execute and approve this release and waiver. I agree that this release and waiver shall be binding on me, the Entrant, and our legal representatives, heirs, assigns and licensees. I have read this waiver and am fully familiar with its contents.
