District of West Vancouver Delegation Bylaw No. 4580, 2008, Amendment Bylaw No. 4591, 2009

A bylaw to amend District of West Vancouver Delegation Bylaw No. 4580, 2008 to create a West Vancouver 2010 Olympic Fundraising subcommittee.

WHEREAS the Council of The Corporation of the District of West Vancouver deems it expedient to provide for the establishment of a West Vancouver 2010 Olympic Fundraising subcommittee

NOW THEREFORE, the Council of the District of West Vancouver enacts as follows:

Part 1 Citation

- 1.1 This bylaw may be cited as "District of West Vancouver Delegation Bylaw No. 4580, 2008, Amendment Bylaw No. 4591, 2009."

Part 2 Severability

- 2.1 If a portion of this bylaw is held invalid by a Court of competent jurisdiction, then the invalid portion must be severed and the remainder of this bylaw is deemed to have been adopted without the severed section, subsequent, paragraph, subparagraph, clause or phrase.

Part 3 Bylaw Amendments

- 3.1 Bylaw No. 4580, 2008 (adopted on October 6, 2008) is amended by:
- (a) eliminating Section 4 (e) and adding to section 4 (f) "two other District officers or employees designated by the Chief Administrative Officer".
 - (b) adding the following to Section 4:
 - (i) 4.1 A select subcommittee is hereby established and is to be known as the "West Vancouver 2010 Fundraising Subcommittee".

- (ii) 4.2 The West Vancouver 2010 Fundraising Subcommittee is a subcommittee of the West Vancouver 2010 Olympic Leadership Committee.
- (iii) 4.3 The following persons are hereby appointed as members of the West Vancouver 2010 Olympic Fundraising Subcommittee:
 - (a) Richard W. Warke;
 - (b) The Mayor of the District
- (c) deleting Section 5(a) and renumbering sections 5(b) to (e) as paragraphs 5(a) to (d) inclusive.
- (d) adding the following after Section 5:
 - (i) 5.1 Subject to all applicable enactments, the West Vancouver 2010 Fundraising Subcommittee shall have the authority to raise funds in relation to the District's participation in the Games.
 - (ii) 5.2 Subject to all applicable enactments, the Chair of the West Vancouver 2010 Fundraising Committee shall have the authority to allocate, disburse and exercise the District's rights and benefits set out in Section 3 of the VANOC Venue City Agreement in accordance with the District of West Vancouver 2010 Olympic and Paralympic Winter Games Ethics and Integrity Policy adopted by Council and the West Vancouver 2010 Olympic Leadership Committee.

Part 4 Offence and Penalty

- 4.1 Every person who violates a provision of this bylaw, or who consents, allows or permits and act or thing to be done in violation of a provision of this bylaw, or who neglects to or refrains from doing anything required to be done by a provision of this bylaw, is guilty of an offence and is liable to the penalties imposed under this bylaw, and is guilty of a separate offence each day that a violation continues to exist.
- 4.2 Every person who commits an offence is liable on summary conviction to a fine or to imprisonment, or to both a fine and imprisonment, not exceeding the maximum allowed by the *Offence Act*.
