1. Each and every one of the hereinbefore mentioned lands is hereby allocated, set aside and dedicated for Park purposes.
2. This By-law may be cited for all purposes as "WEST VANCOUVER MISCELLANEOUS PARKS DEDICATION BY-LAW No. 1091, 1945"
