

I have two cars in my household, so I will pay \$40 per year to Impark and West Van District to enjoy three local parks in my community.


This is not an "exemption" for District residents. This is an annual parking fee we now pay to avoid paying, well, more.

re: Notice of Motion – Dedication of Upper Lands Owned by the Municipality to Public Parkland.

Lambert, P., and Thompson, S., councillors, propose that council dedicate the District-owned lands above the 1200foot elevation contour as one or more municipal parks in perpetuity. This action is not advisable inasmuch as those lands represent significant untapped public wealth which may, and, indeed, might well be a future source of income and revenue to meet the needs of a growing population and infrastructure investment in the future.

Some salient points:

Dedication as park land by a municipal council in perpetuity does not mean the that dedicated lands are, forever after dedication, prohibited from redevelopment as residential and/or commercial uses. <u>Reason</u>: Park dedication can be reversed by a subsequent decision by municipal council with the consent of the Minister.
 Dedication as park land is not a costless transformation of the land. Reason: Once dedicated as park land, pressure will grow on the municipality to provide amenities to the public (trails, washroom facilities, access roads, playgrounds, &c.). <u>Reason</u>: Public parks are destination recreational lands that an ever-growing regional population will seek access to, esp. in light of this council's drive to restrict access to established parks via parking tolls and restrictions; whereas, un-dedicated forest lands (as at present) are wilderness (by comparison) and access by the public is unorganized and infrequent.

3. Undeveloped forest lands represent a form of wealth to the municipality that can be tapped in the future for revenue purposes as well as for expansion of suburban residential and related commercial land use when the lands below the 1200-foot elevation contour are fully developed and can no longer be practicably densified further. <u>Consideration</u>: The 1200-foot elevation contour is an arbitrary limiting constraint that served to limit the cost of infrastructure relating to water-works and sewer-collector works during the last century, but which in future need not constrain the municipality's land use for inhabitation.

4. The municipal council is facing serious financial demands in the remainder of the present century to rehabilitate, renew, and replace built infrastructure in water-works, sewer-collector, and drainage diversion works, including but not limited to impoundment dams, transmission and reticulation works, storage reservoirs, pumping units for water and sewerage, and associated SCADA and civil works, which taken together were estimated in the year 2010 by the municipal engineering department to comprise the expenditure of \$1 billion (2009-dollars) in the course of the 21st Century. <u>Consideration</u>: Council has not, to this writer's knowledge, provided for these expenditures nor identified a source of funding to support the rehabilitation, renewal, and replacement of the existing works, let alone expansion of those works to support the higher density urban and suburban development that the Provincial Government envisions as necessary to meet a growing provincial population in the Lower Mainland.

Although the mover and the seconder mean well, and hope to leave a legacy to future generations of residents of the municipality, the motion is ill-advised from a practical as well as legacy point-of-view. The municipality is endowed with undeveloped lands that represent tangible untapped wealth that should not be walled-off by dedicating it to park land in hopes that it will be a legacy of this council. In terms of real options theory of capital management, the undeveloped undedicated 'upper lands' is a real option that should remain in its present state for the foreseeable future as a form of untapped wealth that belongs to future generations for the wealth that can be obtained to support future capital needs and urban/suburban real estate development which will accommodate future population growth and municipal services, including essential infrastructure rehabilitation, renewal, and expansion, that without those lands remaining undedicated (i.e., the real option remaining unexercised) would not be available to a future council to meet the needs of population growth and rising infrastructure costs.

Dear Mayor and Council

To my shock, the environmentally protected 5m riparian area of fish habitat (with recently installed fish ladders to help the fish) at Lawson Creek, around Duchess and 18^{th,}, had about 3-4 trees cut down and 2-3 trees topped/stripped of all their lower branches (photos below).

As you know, cutting down trees and shrubs and grasses in the environmentally protected riparian areas will, according to accepted science, heat the creek water and ultimately kill the fish and biology of the creek – which is why the Riparian Area Protection Act prohibits healthy tree, shrubs and grass cutting in the 5m and 15m areas.

I have since been advised by an anonymous Staff account called "environment" that it was not cleared out for a cell tower, but for fibre optic equipment and cable, and the District approved this work in our environmentally protected District land saying:

TELUS is installing fibre optic cable on existing BC Hydro infrastructure. Other than the new cable on the existing poles, no new structures are being built. Ahead of the installation, tree work was needed to provide clearance and remove hazards along the BC Hydro right-of-way. The tree work near Lawson Creek was necessary to mitigate hazards to the overhead utilities on the road allowance. The District Arborist and Environmental staff ensured the District contractor completed the work with as minimal impact to the riparian area as possible. Attached is the notice that would have been circulated to residents ahead of this work.

If the flyer attached was delivered, (I didn't receive it and I am about s.22(1))) it says there would be some "pruning" with a photo of a humming bird – whose habit and that of the Great Blue Herson who used to fish in Lawson Creek, they planned to and did actively damage.

Cutting down 3-4 trees and topping 2-3 others is not some "pruning."

Page 16 of this document BC Hydro doc discussing how they allow Telus to use their hydro poles is perhaps a snapshot, diagram to give a general sense of what is they are doing: <u>https://app.bchydro.com/content/dam/BCHydro/customer-portal/documents/distribution/standards/ds-ES43-C1-distribution-pole-attachments.pdf</u>

Since I don't expect a reply to my polite but pointed response to the "environment" email address, I am asking through the Mayor and Council to inquire with the Planning Dept:

1. What sites other than this environmentally protected and sensitive 5m riparian area of fish habitat were evaluated for this work? I am understanding that BC Hydro has a right away and I gather can allow Telus to piggy back on their right of way.

However, there are a lot of streets with hydro poles in WV on which Telus could have put their equipment instead of in an environmentally protected and sensitive fish habitat. Why damage the environmentally protected area?


- 2. What are the justifications for the cutting in the below photos?

- 4. Who do I escalate this to, to require replanting per the RAPR? The District, Telus, Hydro?
- 5. What is being done to avoid a repeat of this situation?


It may be that I am the lone annoying voice on this because people are just generally unaware of environmentally protected riparian areas (as I was up until ten years ago) and what it means (based on accepted science by environmental experts) to our earth and future generations being the destruction of our natural resources including fish habitat, protected trees, and the elimination of the habit of already at risk wildlife, specifically in this case the Great Blue Heron who used to fish in Lawson Creek; and/or those would very much be as concerned as I am, but have not been made aware of what is going on.






5m Legally Protected Envrionmental Area Beside Fish Ladder



The Rural Transit Solutions Fund (RTSF) is the first federal fund to target the development of transit solutions in rural and remote communities. Launched in 2021, the Fund provides support for the development of locally-driven transit solutions that will help people living in rural communities get to work, school, appointments, and to visit loved ones. Eligible organizations representing these communities can seek support through two program streams depending on the nature of their project: (1) Planning and Design Projects, and (2) Capital Projects.

Under the Planning and Design Projects stream, eligible applicants can seek a grant of up to \$50,000 to support communities' projects to plan and design new or expanded transit solutions for their communities (e.g., public engagement, needs assessments, feasibility or viability studies, surveys and assessments of routes or modes of travel). Capital Projects can cover a broad range of activities related to the delivery of rural transit solutions. Proposed solutions could include a range of modes of eligible transport, including traditional solutions such as fixedroute buses and non-traditional solutions such as ride-share or on-demand services requiring the purchase of minivans, small craft, zero-emission fleets, shared fleets, the construction of intermodal hubs, the installation of charging stations or the purchase of software.

Please be advised that the application process for the Capital Projects stream will close on Wednesday, February 28, 2024 at 12:00 p.m. PST. Infrastructure Canada will continue to accept applications for the Planning and Design Projects stream on a continuous basis and no closing date has been announced.
