Dear Mr. Sager and Council Members,

It seems to me that the objective of introducing paid parking at the West Vancouver parks and other recreational facilities should be so that persons who do not otherwise contribute to the development and maintenance of these facilities pay a fair share for the opportunity to enjoy them. Clearly, this excludes District residential property owners, who contribute to these costs within their property taxes.

I fail to understand why, in addition to already paying for this basic right, District taxpayers should be burdened with an additional penalty.

I respectfully submit that a fair and equitable solution is to;

- institute paid parking at all West Vancouver parks, trails, beaches and all other recreational facilities,
- install "Residents Only" signs where appropriate, on neighbouring streets adjacent to the facilities.
- provide all West Vancouver residential property owners with one or two decals, similar to the Handicapped decals. This could be at a one time nominal cost of, say, \$20, to offset the cost of production.

Please give this proposal your consideration, and rescind the bylaw requiring Residents to pay an annual fee per car.

Good day,
I am responding to the new parking fees West Vancouver has implemented.

My concern is the amount of money I, and assuming many others, who spend the day (around 8 hours) will find this a hardship to visit these beaches on a regular basis. At a rate over \$5 per hour (includes taxes, fees etc) we are looking at over \$40 per day.

My wife and I are retired seniors living on a reduced budget, and will have to look elsewhere to enjoy our north shore (where, who knows). We have over the [REDACTED] s. 22(1) years enjoyed spending our days at Whytecliff beach during the summer months. Generally 3-4 times per week. At your imposed hourly rates (with no day passes like Stanley park, Sasamat lake have in place) we are looking at over \$160 per week, or about \$1200 over the summer. So much \$\$ to enjoy our "public beaches".

With these rates I would see a lot of visitors, like ourselves, looking elsewhere for our enjoyment in the sun.

If this is true a lot of these visitors would have spent \$\$, visiting the commercial outlets, for meals, shopping etc. This is something you should consider as well for reducing your fees..

I do hope you will look further into the rates and make some adjustments so that "everyone", not just west vancouver can visit without trying to worry about their budget.

Hello,

I am writing with respect to the new parking system introduced for Whytecliff Park and Lighthouse Park.

I am a senior from Vancouver who uses Whytecliff Park approximately once per week for walking and quiet reflection.

I've been doing so for a number of years and my visits to West Vancouver typically include stopping to shop at various merchants in Ambleside and Dundarave.

I am concerned with the high cost of the parking program. It's advertised as \$3.75 per hour but with taxes and fees the actual cost is \$5.23 per hour. This means a \$15.69 add-on to a three-hour outing. No money would be left over to visit the coffee shops and restaurants in West Vancouver on these outings.

This is a prohibitive cost. I am already renting a vehicle to get there. While your parking fees include a "translink tax", the park is not accessible by transit. There are no sidewalks on the road and the roadway is very narrow to access the park.

Additionally, I am not able to walk long distances, and your fees provide no discount for handicapped seniors.

I would be happy to pay for a \$20 parking pass but these are not available to Vancouver residents, and they are tied to one specific vehicle whereas my rental cars always have different license plate numbers.

Further, there is no way to pay for parking without a cell phone. I don't always use a mobile phone and do not have access to the internet on my phone.

This seems like a dangerous precedent to lock out the poor and elderly, and even just average working people from using these parks which are special "jewels" within the Province of BC.

Would you kindly reconsider this new parking scheme? Surely there are other ways to raise funds.

Dear Mayor Sager,

Attached is a letter describing what happened to my wife on [REDACTED] s.22(1). This was a terrible incident that left my wife injured, in the hospital, in extreme distress and pain caused by a simple trip on one of West Vancouver's poorly maintained sidewalks. My wife fell under a parked pickup truck. Fortunately, it was not moving. And also fortunately, the driver did not return to roll over her as he pulled away from the parking spot! I believe this would have been avoidable had the sidewalk been maintained in a safe condition.

I think you should aware of this incident as it is likely to happen again. I have no way of knowing how many other incidents have involved other victims who have suffered a similar fate. I would like to know how long ago those orange strips were painted. Surely, we do not plan to use that as substitute for a proper repair. I sincerely hope you will communicate with the Engineering Dept. to assess these locations and make the necessary improvements as soon as possible.

Re: Tripping incident near 16th St. and Bellevue Ave.

Mayor and Council,

At approximately midday on [REDACTED] s.22(1) this year (2024) my wife was walking south on the East side of 16th St. between Marine Dr. and Bellevue Ave. when her foot became caught in an uneven piece of the sidewalk. She was sent sprawling forward into a very nasty tumble.

She was helped by a couple of strangers who recognized she was injured and called for the ambulance. She was taken by ambulance to Lions Gate Hospital.

X-rays revealed [REDACTED] s.22(1)

There are many uneven tripping hazards around West Vancouver. The location of this incident has an orange strip of paint across two parts of this uneven pavement. This is supposed to serve as a warning to pedestrians of West Vancouver. It is ineffective.

How long have these two orange strips been there? What is the date these strips were painted? They are quite faded right now. Why has something not been done to this location and other locations in the municipality?

In today's world graffiti is evident on walls, roads, sidewalks and even the change rooms of the West Van. Rec. centre. This ugly defacing of property has gone unchecked for a long time. A faded orange stripe now has no significance to an unsuspecting pedestrian. A splashing of paint does not relieve responsibility of duty to protect members of their community.

My wife is [REDACTED] s.22(1) old. I can only ask that West Van Council and Engineering take steps to attend to these long-neglected projects and avoid more tragic events for our seniors and indeed all residents and visitors to our community. It is a shameful situation!

“When the money runs out, the thinking has to begin.” - Thomas Sowell.

“It is a popular delusion that government wastes vast amounts of money through inefficiency and sloth. Enormous effort and elaborate planning are required to waste this much money.” - PJ O’Rourke.

Some thoughts to ponder before casting a vote to continue enabling our District’s long-standing curse of chronic fiscal incontinence.

During the 2022 municipal election campaign mayoral candidate Sager made some explicit commitments to the electors of West Vancouver. Specifically, in his campaign literature, he said, “As Mayor, I will commit to re-introduce the Finance Commission.” To date, this has yet to be done. Instead, we are evidently to get the recently announced ‘RoundTable’, the mandate of which is apparently merely to advise Mayor and Council on potential new sources of revenue. Nothing whatsoever respecting the provision of advice on getting the District’s operating expenses down. The publication of terms of reference for this advisory group ought to be imperative, as well as a time-line for deliverables and a brief description of who has been appointed to the group and why.

In his promotional literature, candidate Sager also said, “I will ensure that we take our responsibility for fiscal management seriously....all expenses will need to be fully justified to ensure value for taxpayers, including a line by line analysis of dollars spent which I commit to personally reviewing. With the assistance of a newly configured Finance Commission, which will tap into some of the brightest minds in our community, I am confident we can hold the line on expenses without impacting community services. With the prospect of a potential recession, there has never been a more important time to have people with real experience setting the budget.”

As I understand it, the RoundTable is to hold its initial meeting on February 28th next. So Council is about to vote, on February 26th next I believe, on the second District budget to be put before it without benefit of advice from “people of real experience”. And, in any event, as of now it appears RoundTable members are not to be asked for advice on budget-setting.

Our Mayor and four of our Councillors, those who sought election as part of an informal ‘slate’ with him, were handed an enormous electoral mandate in October, 2022. This support was in good measure based on their commitments made respecting a much improved approach to the management of taxpayers’ money. Evidence of this commitment has yet to be seen.

In particular, the District’s proposed budget for 2024 does not appear to have been subjected to the analytical rigour explicitly or implicitly promised by mayoral candidate Sager and those candidates for Council who sought office alongside him. In particular, it has not been put before “some of the brightest minds in our community...people with real experience” before being presented to Council for their consideration. In the circumstances, I respectfully suggest that

neither our Mayor nor any of the four Councillors referenced above can in good conscience vote to approve this budget as presented. It must first be subjected to a thorough vetting by qualified volunteers from our community, just as mayoral candidate Sager promised would be done. It is a matter of personal integrity.

And speaking of integrity, in his campaign literature mayoral candidate Sager had this to say about the introduction of a pay parking scheme in West Vancouver parks, "We can implement a pay for parking system which exempts West Vancouver homeowners (they pay enough already), but charges others." So, why pray tell has Council recently implemented a scheme which fails to exempt West Vancouver homeowners, the ones who "pay enough already"? A scheme by the way which has desecrated certain of our parks with obnoxiously aggressive signage and which requires disclosure to a commercial enterprise hired to oversee it of West Vancouver residents' personal information it ought not to possess.

7. Review Proposed Municipal Art Collection Policy

The Committee was requested to endorse the proposed Municipal Art Collection Policy before it is submitted for Council consideration on February 26, 2024. In 2023, the Public Art Advisory Committee and the Art Museum Advisory Committee worked on reviewing the policy and the two procedures connected with the Policy: Municipal Art Collection Public Art Procedure and the Municipal Art Collection Art Museum Procedure. These documents have not been reviewed since 2005. Key changes to the Policy include:

- Incorporating the Art Museum's collection policy and procedures into the overall District's Municipal Art Collection Policy;
- Incorporating Council resolutions since 2005 regarding the funding of public art through Community Amenity Contributions;
- Addition of policy regarding the repatriation of Indigenous Cultural Material which follows best practices of provincial and national organizations;
- Reference to working with the Squamish Nation, Tsleil-Waututh Nation, and Musqueam Nation to interpret First Nations culture and history in accordance with the peoples concerned and the Truth and Reconciliation Commission of Canada: Calls to Action; and
- Updates to the levels of authority required for the acceptance of donated, purchased, or commissioned works based on the value of the artwork(s) which is relevant to both the West Vancouver Art Museum and the District's Public Art Program.

The Procedure documents will be presented to the Municipal Manager for approval so were not presented to the Committee for review.

The Committee reviewed the proposed Municipal Art Collection Policy and recommended clarity in the wording in section 5.1 for levels of authority at or under \$10,000 and over \$10,000.

It was also noted that in Section 3.8 under Public Art Reserve Fund that there were more recent Council decisions regarding the allocation of 1% of unrestricted Community Amenity Contributions to the Reserve Fund. Staff to update this section from the Use of Community Amenity Contributions Policy 0131 approved in 2021.

THAT the Arts & Culture Advisory Committee endorses the proposed Municipal Art Collection Policy, with corrections as noted.

Dear Friends & Neighbours,

Every senior in Canada deserves to age in dignity, safety, and comfort, regardless of where they live. That is why the Government of Canada is investing close to \$200 billion over 10 years, which includes \$5.4 billion for tailored bilateral agreements with provinces and territories on [Aging with Dignity](#).

This week, the Government of Canada announced a bilateral agreement to invest \$733 million over the next five years to help British Columbians age with dignity, closer to home, through improved access to home and community care and long-term care (LTC). This funding builds on the \$1.2 billion bilateral agreement that was announced with the province in October of 2023.

Federal funding will support British Columbia's five-year action plan to improve health care for seniors. The plan will:

- **Expand home and community care services**
 - Continue to expand and integrate home and community care services for seniors with complex medical conditions and frailty to better meet their needs and help reduce pressures on hospitals and emergency departments.
- **Improve the availability of palliative and end-of-life care**
 - Increase access to palliative and end of life care for people outside hospital settings, enabling them to have these supports in their home, hospice, or community settings.
- **Improve the quality of long-term care services**
 - Improve dementia care through implementation of evidence practice knowledge, standardized education, and monitoring tools.
 - Strengthen the appropriateness, safety, and quality of LTC by enabling consistent, appropriate standards of care and oversight of LTC services.
 - Support aging in place through connecting frail seniors in their homes to a new outreach program through long-term care providing supports, services and respite care.
 - Support the delivery of excellent long-term care through improved long-term care experience for residents, by hiring and training diverse, skilled staff, and enhancing working conditions in LTC facilities.

Progress on these initiatives and broader commitments will be measured against targets which British Columbia will publicly report on annually.

Through this new agreement and the Working Together agreement signed in October 2023, British Columbia will improve how health information is collected, shared, used and reported to Canadians; streamline foreign credential recognition for internationally educated health professionals; and facilitate the mobility of key health professionals within Canada; and fulfill shared responsibilities to uphold the *Canada Health Act* to protect Canadians' access to health care that is based on need, not the ability to pay.

Recognizing the significant disparities in Indigenous health outcomes, the Government of Canada and British Columbia also commit to meaningfully engage and work together with Indigenous partners to support improved access to quality and culturally appropriate health care services. British Columbia action plan is informed by continued engagement with its Indigenous partners and recent trilateral discussions involving the federal government. All levels of government will approach health decisions in their respective jurisdictions through a lens that promotes respect and reconciliation with Indigenous Peoples.

British Columbia and the federal government will continue working together to improve access to health services and deliver results for seniors across the province, including responding to the needs of Indigenous and other underserved and disadvantaged populations.
