Road Closure and Removal of Highway Dedication Bylaw No. 4389, 2004

A Bylaw to close up and remove the dedication of a portion of highway.

WHEREAS under the *Community Charter* a Council may close a highway to traffic, remove the dedication of a highway and dispose of municipal land;

WHEREAS the Council of the District of West Vancouver deems it expedient to provide for a closure of a portion of highway and to remove the dedication of that same portion of highway;

WHEREAS Council has posted and published notices of its intention to close the highway referred to in this Bylaw and remove its dedication, and has provided an opportunity for persons who consider they are affected to make representations to Council;

WHEREAS Council does not consider that the closure will affect the transmission or distribution facilities or works of utility operators;

NOW THEREFORE, the Council of the District of West Vancouver enacts as follows:

Part 1 Citation

- 1.1 This Bylaw may be cited as the Road Closure and Removal of Highway Dedication Bylaw No. 4389, 2004.

Part 2 Severability

- 2.1 If a portion of this bylaw is held invalid by a Court of competent jurisdiction, then the invalid portion must be severed and the remainder of this bylaw is deemed to have been adopted without the severed section, subsection, paragraph, subparagraph, clause or phrase.

Part 3 Previous Bylaw Repeal

- 3.1 Road Exchange Bylaw No. 4346, 2003 (adopted February 09, 2004) is hereby repealed.

Part 4 Substantive Provisions

- 4.1 Attached to this Bylaw as Schedule "A" and forming part of this Bylaw is a copy of a reference plan of highway closure (the "Plan").
- 4.2 Council hereby authorizes the closure to all types of traffic of that portion of highway dedicated by plan 2103 having an area of 186 square metres as shown hatched and marked Parcel 'A' on the Plan (the "Closed Road").
- 4.3 The dedication as highway of the Closed Road is removed.
- 4.4 The Mayor and Clerk are hereby authorized to execute all plans and other instruments as are necessary to effect the aforesaid closure and removal of highway dedication.
- 4.5 On deposit of the Plan and instruments necessary for the road closure in the Land Title Office:
- 4.5.1 the Closed Road is stopped up and closed to all types of traffic and shall cease to be a public highway; and
- 4.5.2 the dedication of highway within the Closed Road is removed.
