Road Closure and Removal of Highway Dedication Bylaw No. 4786, 2014

A bylaw to close up and remove the dedication of a highway located adjacent to, and south of, the Mulgrave School site on Cypress Bowl Road, West Vancouver

WHEREAS under the Community Charter a Council may close a highway to traffic, remove the dedication of a highway and dispose of municipal land; and

WHEREAS the Council of the District of West Vancouver deems it expedient to provide for the closure to traffic and removal of the dedication of that portion of the unimproved dedicated road located south of and adjacent to the Mulgrave School lands and more particularly described in this bylaw; and

WHEREAS the Council does not consider that the closure will affect the transmission or distribution facilities or works of utility operators; and

WHEREAS Council has posted and published notices of its intention to close the highway referred to in this bylaw and remove its dedication, and has provided an opportunity for persons who consider they are affected to make representations to Council;

NOW THEREFORE, the Council of the District of West Vancouver enacts as follows:

Part 1 Citation

- 1.1 This bylaw may be cited as Road Closure and Removal of Highway Dedication Bylaw No. 4786, 2014.

Part 2 Severability

- 2.1 If a portion of this bylaw is held invalid by a Court of competent jurisdiction, then the invalid portion must be severed and the remainder of

this bylaw is deemed to have been adopted without the severed section, subsection, paragraph, subparagraph, clause or phrase.

Part 3 Substantive Provisions

- 3.1 Attached to this bylaw as Schedule "A" and forming part of this bylaw is a copy of a reference plan of highway closure (the "Plan").
- 3.2 The portion of highway dedicated by Plan 4828 shown as Closed Road and outlined in bold on the Plan is closed to all types of traffic.
- 3.3 The dedication of the highway of the Closed Road is removed.
- 3.4 The Mayor and Clerk are authorized to execute and deliver such transfers, deed of land, plans and other documents as are required to effect this road closure and removal of highway dedication.
