Road Closure and Removal of Highway Dedication Bylaw No. 5007, 2019

A bylaw to close and remove the dedication of a highway located at Lot 6 of the Evelyn by Onni development site.

WHEREAS under the *Community Charter* Council may by bylaw close a highway to traffic and remove a dedication of highway; and

WHEREAS “highway” includes a street, road, lane, bridge, viaduct and any other way open to public use, other than a private right of way on private property; and

WHEREAS Council published notices of its intention to close and relocate the dedication of the highway referred to in this bylaw, and has provided an opportunity for persons who consider they are affected by this bylaw to make representations to Council; and

NOW THEREFORE, the Council of The Corporation of the District of West Vancouver enacts as follows:

Part 1 Citation

- 1.1 This bylaw may be cited as Road Closure and Removal of Highway Dedication Bylaw No. 5007, 2019.

Part 2 Road Closure and Removal of Highway Dedication

- 2.1 Attached to this bylaw as Schedule A and forming part of this bylaw is a reduced copy of Reference Plan EPP90276 dated February 7, 2019 and prepared by Butler Sundvick (the “Plan”).
- 2.2 In this bylaw, the area of land shown outlined in heavy black and labeled as “Parcel A” on the Plan, which area was dedicated as road by the deposit of Plan BCP50603, New Westminster District, is referred to as the “Closed Road”.
- 2.3 The Closed Road is closed to all types of traffic and the dedication as a highway of the Closed Road is removed.

- 2.4 The Mayor and Corporate Officer are authorized to execute and deliver such documents as are required to give effect to the road closure and removal of highway dedication described in section 2.3 of this bylaw.
- 2.5 The District is hereby authorized to transfer the Closed Road to Onni Taylor Way Properties in exchange for the dedication as road of the area of land shown outlined in heavy black and labeled “Evelyn Walk” on the drawing attached to this bylaw as Schedule B, and the Mayor and Corporate Officer are authorized to execute and deliver such documents as are required to give effect to the land exchange authorized by this section 2.5.

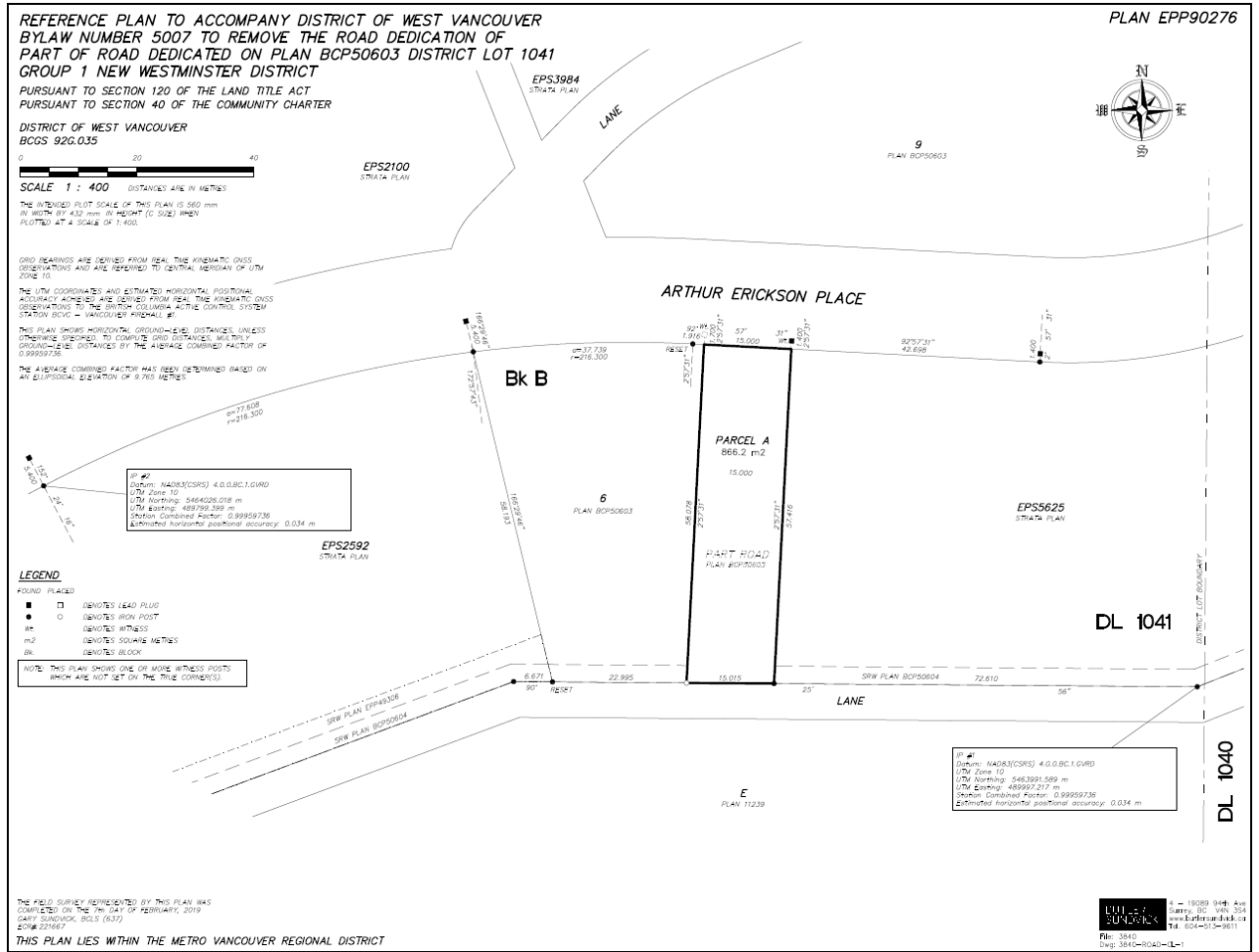
